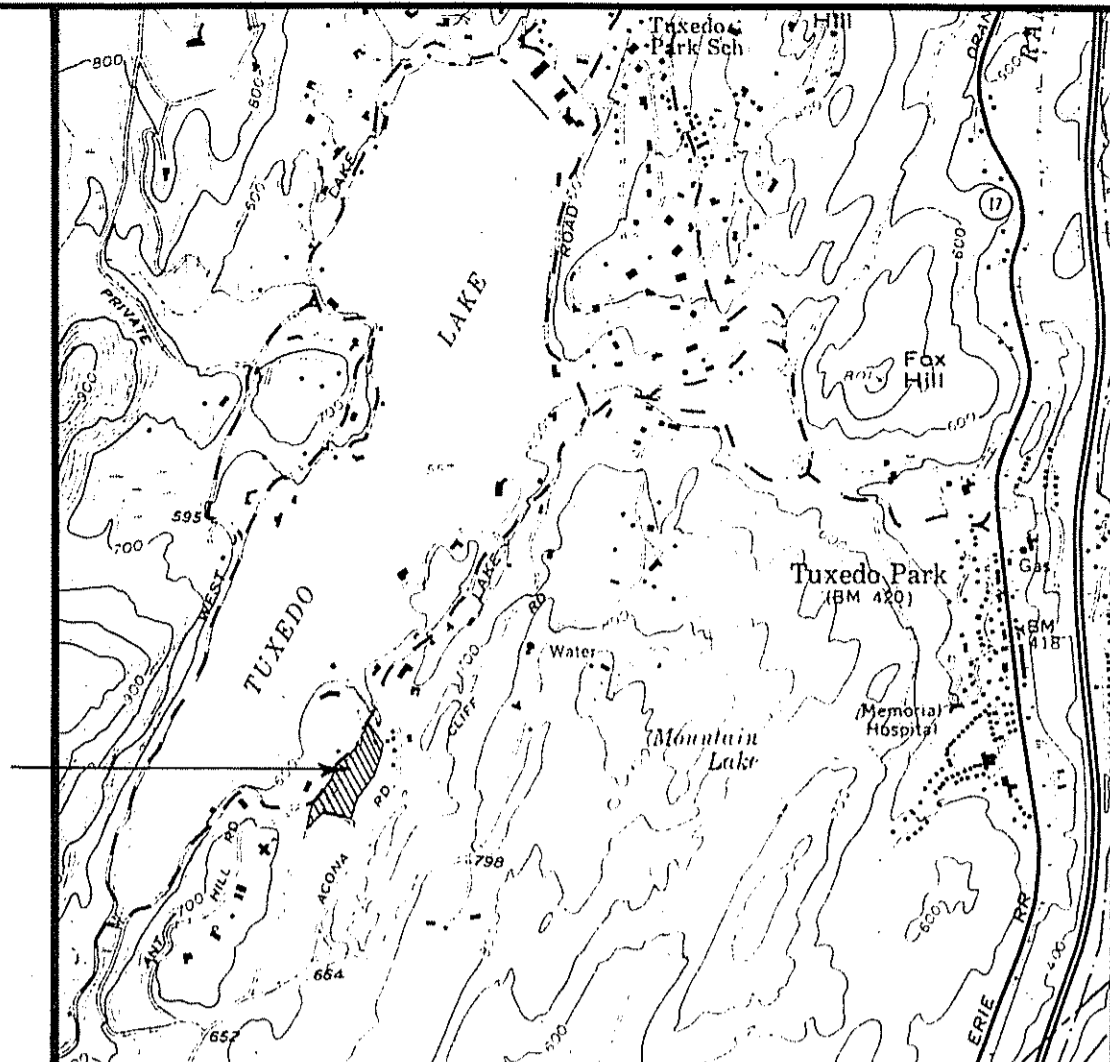

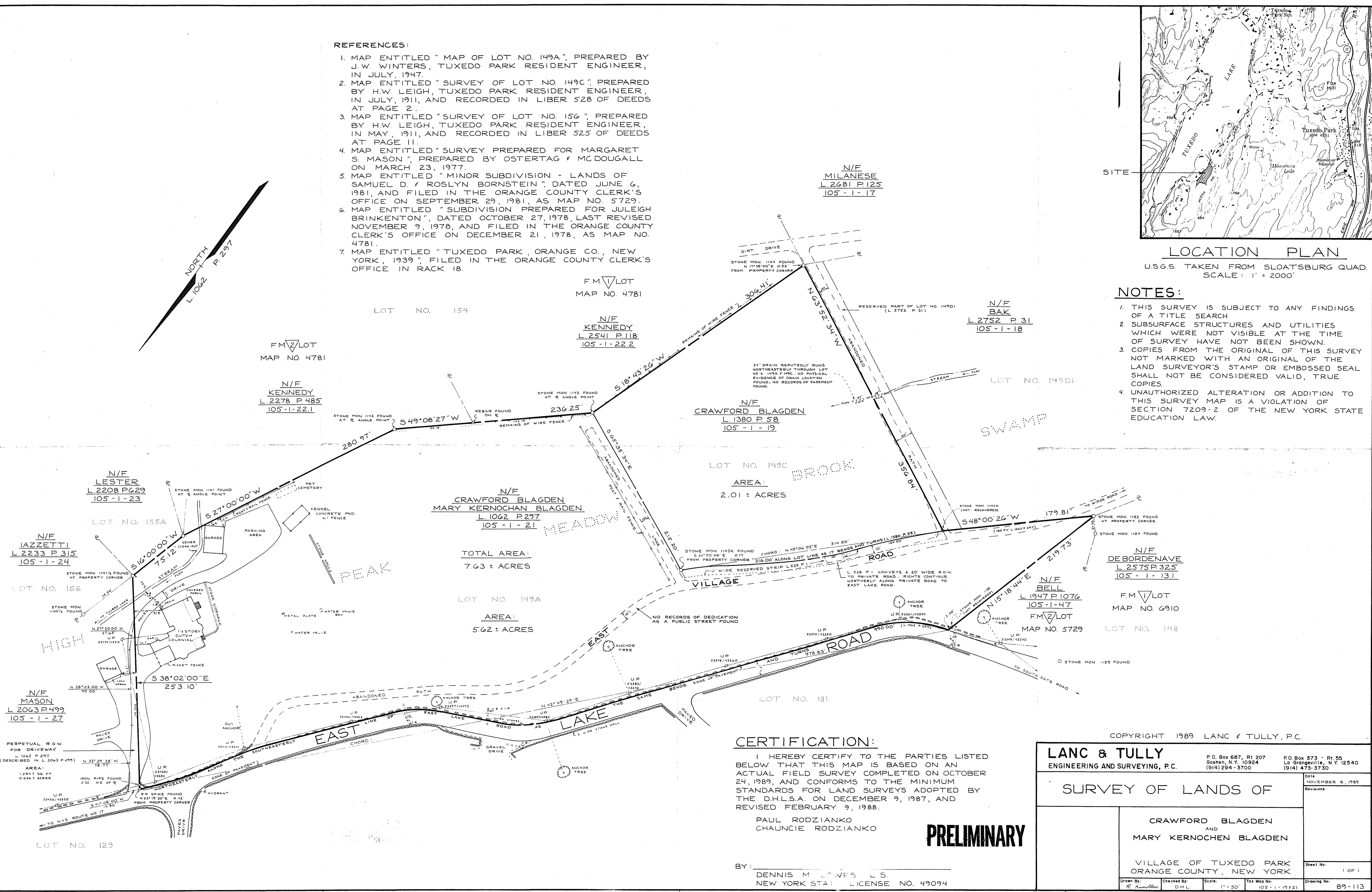
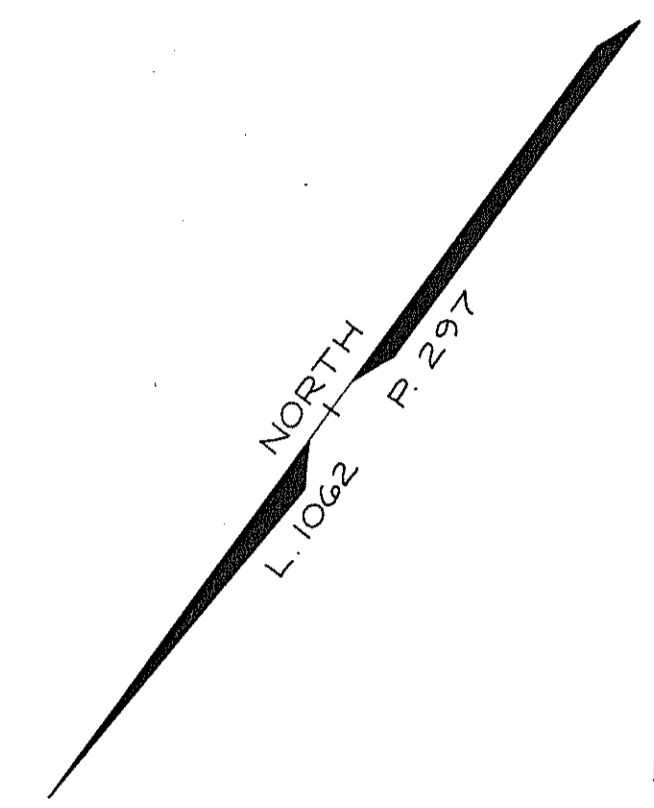


LOCATION PLAN
