The Ralph E. Ogden Foundation will be honored for their longtime commitment to land conservation and for their vision in launching the 270acre Chester Agricultural Center. A partnership between Northeast Farm Access, Orange County Land Trust and a group of social impact investors, the CAC works with new organic farm start-ups to provide for long term and secure access to farmland. There are currently five new organic farms operating on site.

According to Benefit Chair Michael J. Bruno of Tuxedo Park, the theme for this year's Benefit Reception is "Investing in Farms, Food and People."

The evening will be a celebration of land conservation, the bounty of Orange County farmland, and the people who are helping ensure agriculture remains a vibrant and valuable part of Orange County's economy and heritage.
